#### **OUTREACH AND ENGAGEMENT INITIATIVES**

In Fall 2013, I co-authored a report with my Graduate Research Assistant Matthew Cook on the experiences of skilled migrants in Norway. The report was funded by the Office of Research and Engagement and FAFO, the Institute for Labor and Social Research in Oslo, Norway (<a href="http://www.fafo.no/pub/rapp/20334/20334.pdf">http://www.fafo.no/pub/rapp/20334/20334.pdf</a>). I co-organized a seminar with a FAFO colleague to launch the report in Oslo, Norway in November 2013. I presented the research results, followed by comments from an engineer from Portugal, a human resource manager, and

representatives for a labor union for engineers and a union of Norwegian employers. Over one hundred stakeholders attended the seminar.

I discussed the research findings of my NSF-funded project on the governance of international skilled migration (award 1155339, web site <a href="http://www.skilledmigration.net">http://www.skilledmigration.net</a>) in a panel on foreign-born skilled workers at the Global Mobility Forum in Oslo, Norway in November 2013. The panel discussed the obstacles that skilled workers experience, and how these issues can be addressed.

In January 2014, I was invited by the Norwegian Society of Graduate Technical and Scientific Professionals, Tekna, to present my research findings. Tekna had organized a seminar at its headquarters in Oslo to discuss the needs of foreign-born skilled migrants in Norway. Presenters and Tekna representatives exchanged ideas how the labor union could best design programs to improve the legal and professional conditions of foreign-born engineers in Norway.

I also promote community engagement in my graduate course in Qualitative Methods (GEOG 516). I provide examples how students can include outreach activities in their research design.
