PROFESSIONAL HISTORY

I am employed as a Professor in Sociology at Uppsala University and currently lead an ERC Project: JUSTEMOTIONS (2018-2025), and I am cofounder and leader of the Research Group 'Emotion-Justice-Interaction' (EmoJI) at the Department of Sociology. I am chief editor of *Frontiers in Sociology Emotion Section*, 2010-2017 I was employed as a Lecturer/Researcher at Stockholm University and gained the title of Docent in 2016. From 2015-17 I was Coordinator of the European Sociological Association Emotions Research Network (RN11) and still serve in the Advisory Board. Before my graduate studies, I worked as a Director's assistant at several theatre companies and studied acting at The Neighborhood Playhouse School of the Theatre in New York 1991-1992.

RESEARCH INTERESTS

My main research orientation concerns the sociology of emotions and my theoretical interest includes rationality/objectivity, social interaction, decision making, emotional cultures, and professionalization processes. I have been engaged in several research projects that investigate emotions in court from several perspectives: how emotions are active and acted upon in and around court hearings, and how objectivity is constructed in judicial decision-making from an international, comparative perspective. Other research interests include qualitative methods, theatre and acting, interdisciplinary emotion theory, socio-legal research.
