CURRENT POSITION

I currently have a permanent employment (tillsvidareanställning) as a *researcher* at the Department of Peace and Conflict Research (DPCR), Uppsala University (80% research, 20% teaching). I am the *project leader* of two collaborative projects:

- "The Urban Dilemma: Urbanization and ethnocommunal conflict" (Swedish Research Council, 2018-03924), which analyzes how urban politics and urban-rural dynamics shape the risk of intergroup conflict in rapidly growing cities in sub-Saharan Africa. Within this project, I conduct research on Nairobi (Kenya) as well as quantitative research using global data.
- "The Continuation of Conflict-related Violence in Postwar Cities: Mapping violence at the street level" (Swedish Research Council, 2019-02563), which combines the collection of micro-level geocoded data with in-depth case studies to analyze intracity patterns and dynamics of violence in postwar cities. Within this project, I oversee data collection and am main responsible for quantitative analysis and systematic case comparisons.
