Summary

Maria Ågren is a Swedish historian who specializes in early modern and nineteenth- century history. Her scholarly production is extensive, in both Swedish and English, and has been published by e.g., UNC Press, Manchester University Press and Oxford University Press. She is the leader of the large Gender and Work project at Uppsala University, within which the GaW database has been developed as an example of Digital Humanities. She has supervised 18 Ph.D. students to completion of their doctorates. She has broad academic experience, e.g. as chair of one of Uppsala University's recruitment panels (Faculty of Arts), as chair of one of the panels at the Swedish Research Council and as Sweden's representative in the European Science Foundation's Standing Committee for the Humanities.
