IV. Other

As director of the Swenson Swedish Immigration Research Center at Augustana College in Rock Island, Illinois since 1985, I have been responsible for the developing a national library, archives, and research institute for Swedish-American studies. My job duties have included all aspects of the work of such an institution, including research, maintaining and developing an archives and a library, personnel issues, financial and budget matters, contacts with similar institutions in the U.S. and Sweden, and strategic planning.

One important dimension of my work at the Swenson Center has been to promote research in the field. So far, I have arranged ten conferences in the field of immigration and Swedish-American studies at Augustana College, Rock Island, North Park University, Chicago, and Minnesota Historical Society, St. Paul, Minnesota (see above for full description.)

I also established the annual O Fritiof Ander Lecture Series in Immigration History. So far 21 such lectures have been delivered. Contacts with other scholars and research institutes on both sides of the Atlantic have been many, and a several cooperative projects have been initiated. Since 2009 the Swenson Center also works closely with the National Library of Sweden and the Minnesota Historical Society in a major project to digitize Swedish-language newspapers in the U.S.

Swenson Center currently has three full-time employees and a number of volunteers. Its annual budget is around \$200,000. It is privately financed and has an endowment, which currently is valued at approximately \$3,000,000.

Administrative courses

I have taken the course "Finances for Department Chairs" at Uppsala University and a special leadership course organized by Uppsala University, called "Creativity and Leadership."

Educational planning and administration

For a quarter of a century, 1983-2008, I served as co-director of the Augustana College Summer School in Sweden, an intensive summer school program in Swedish offered annually or bi- annually by Augustana College at Grebbestads folkhögskola in Grebbestad, Sweden. The course consisted of circa 25 American students who spend five weeks in Grebbestad and one week in Stockholm studying Swedish language and culture on three levels. The course corresponded to one year of study in the U.S. and students receive one year of Augustana College credit. My job duties were extensive and included all aspects of running this kind of summer program: administrative, financial, pedagogical, cultural, social, and therapeutic.

As director of SINAS at Uppsala, I have the overall responsibility for developing its courses in American studies.

Personnel and financial planning and administration

I have extensive experience of personnel and financial planning and administration from my position in the U.S. In addition, I have served as chair of a department in Uppsala for two years.

Leadership positions

Between 2004-2007 I served as deputy director and director (=department chair) of the Centre for Multiethnic Research at Uppsala University. I participated in many aspects of the planning and development of the department's life, and represented the Center in many contexts. I have served as director of graduate studies (studierektor för forskarutbildningen) at the English Department at Uppsala. In 1999 I headed committee for the examination of social and ethnic diversity at Uppsala University, and I served as the chair of the university-wide committee for social and ethnic diversity at Uppsala 2000-2009.

In my American life I have since 1985 been the director of a research institute, library, and archives, which has included many different leadership duties and challenges.

Interaction with broader aspects of society

I have significant experience from interactions with society. I lecture frequently on the history of Swedish migration to the United States to general audiences in both Sweden and the U.S. Since I assumed the directorship of SINAS I have become a (very) frequent commentator on American politics and society in Swedish media, both on television and in newspapers. In 2016 I was the most frequently interviewed/quoted scholar from Uppsala University in the Swedish media.
